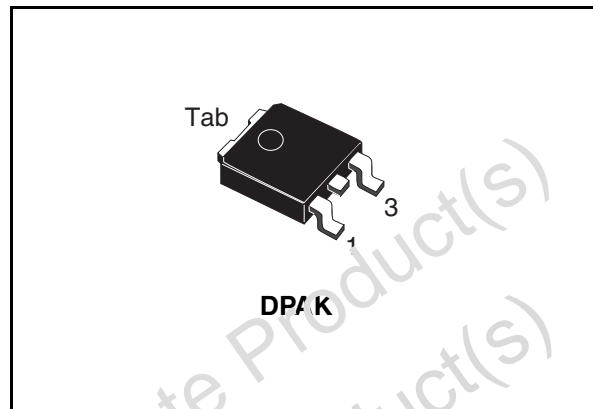


Figure 1. Internal schematic diagram

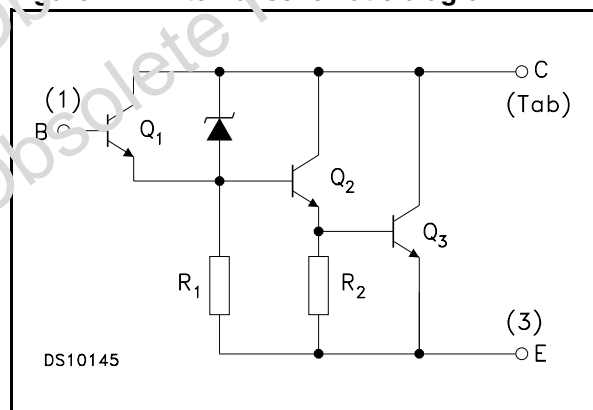

Figure 2. DC current gain

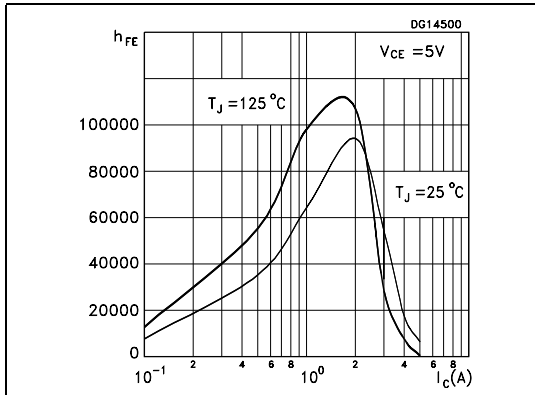


Figure 3. Collector-emitter saturation voltage

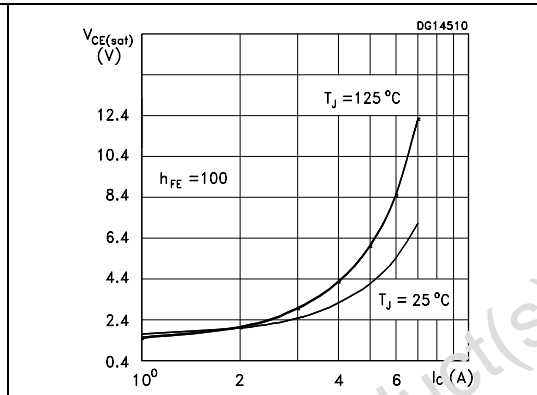


Figure 4. Collector-emitter saturation voltage

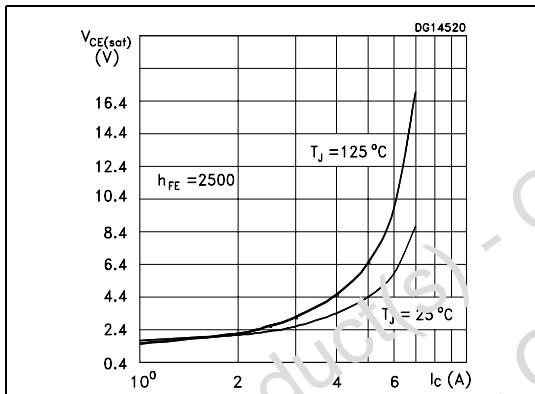
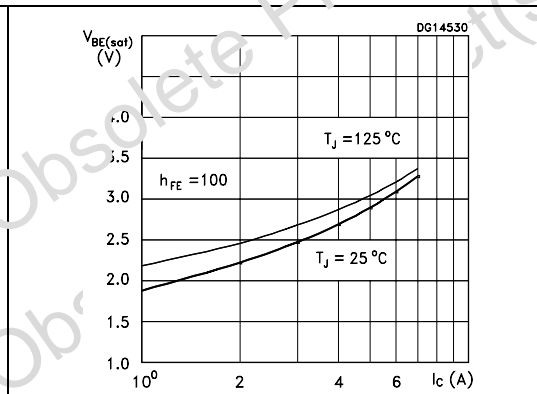


Figure 5. Base-emitter saturation voltage



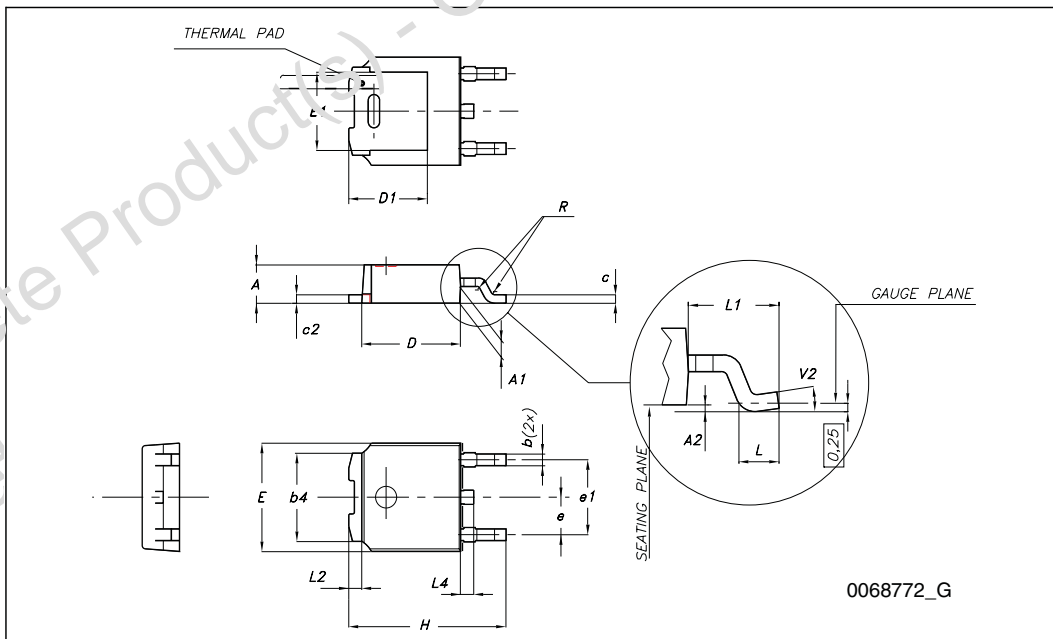
3 Package mechanical data
