

### **Description**

The STEVAL-MKI153V1 is an adapter board designed to facilitate the evaluation of the H3LIS331DL 3-axis, high-g accelerometer in the MEMS product family. The board offers an effective solution for fast system prototyping and device evaluation directly within the user's application.

The STEVAL-MKI153V1 can be plugged into a standard DIL24 socket. The adapter provides the complete H3LIS331DL pinout and comes ready to use with the required decoupling capacitors on the VDD power supply line.


This adapter is supported by the STEVAL-MKI109D evaluation platform, which includes a high-performance 32-bit microcontroller functioning as a bridge between the sensor and a PC, on which it is possible to use the downloadable MEMS Studio graphical user interface or dedicated software routines for customized applications.
