## APPLICABLE LAW AND JURISDICTION

This Agreement shall be governed, construed and enforced in accordance with the laws of Switzerland, without regard to its conflict of laws rules. The UN Convention on Contracts for the International Sale of Goods shall not apply to this Agreement. In case of dispute and in the absence of an amicable settlement, the only competent jurisdiction shall be the Courts of Geneva, Switzerland. Any breach of this Agreement by You may result in irreparable damage to ST for which ST will not have an adequate remedy at law. **RELATIONSHIP OF THE PARTIES**

Nothing in this Agreement shall create, or be deemed to create, any joint venture, partnership, principal-agent, employer-employee or other relationship between the Parties, except that of independent contractors. Neither Party has the authority or power to bind, to contract in the name of, or to create a liability for the other in any way or for any purpose.

**SURVIVAL**

Any provision of this Agreement which imposes an obligation after termination of this Agreement shall survive the termination of this Agreement.

**RECYCLING**
